These are examples where the rights of children are not being protected.

Let's consider what it means for children to grow up comfortably and healthily.



Introduction to the Mie Prefecture Children's Ordinance

This ordinance was established with the aim of creating a society where the rights of children are secured, in accordance with the principles of the Convention on the Rights of the Child.

Important points of the ordinance (basic principles)

Children have intrinsic rights, and shall not face discrimination for any reason



Like adults, children have many rights, including some that only children have.

Children shall not face discrimination for any reason, including ethnicity, gender, ways of thinking, disability, or economic circumstances.

Children can express their own opinions and participate in various social activities



Children can freely communicate their own thoughts and opinions to adults.

They can participate in social activities at schools and within local communities, and the opinions of children can be utilized in society.

Children's lives and health shall be protected, to ensure they can grow up healthily



Children shall be protected from crime, accidents, and other dangers, and shall be able to grow up healthily.

The opinions of children shall be respected, and their best interests shall be considered



The opinions of children shall be valued. Adults shall prioritize what is best for children when considering things.

Convention on the Rights of the Child

This convention was adopted by the UN General Assembly in 1989. Japan became a signatory in 1994. It recognizes that children have rights as human beings, like adults, and establishes that children also have unique rights, because care and consideration are necessary for their growth.

What adults do for children

Every adult plays a role in protecting the rights of children. Adults must cooperate to support children.

Parents and guardians

These adults shall understand that it is their responsibility to take care of children as they grow, and they shall endeavor to create an environment where children can grow with peace of mind, with support as required from administrative bodies, supporting organizations, and other groups.

Business operators

Business operators shall provide a workplace environment that enables working people to lead a fulfilling life that balances work and home. They shall also endeavor to promote initiatives to support the growth of children in local communities.

Schools and other educators

These adults shall endeavor to ensure the safety of children, and create an environment where children can learn and grow with peace of mind.

They shall provide support to ensure that children can learn about children's rights and express their opinions.

Supporting bodies

They shall endeavor to watch over and support the growth of children, through activities that utilize their specialist knowledge.

Coordination Cooperation

Residents

They shall endeavor to deepen their understanding of measures related to children, and actively cooperate with such measures.



Prefectural government


The government of Mie Prefecture shall systematically promote measures related to children, and shall value the opinions and best interests of children. We will work with municipal governments to provide support to enable cooperation by parents and guardians, schools, and the local community, and support initiatives in which everyone works together to support children.

Mie Prefecture's efforts

We protect children from abuse, bullying, and other violations of their rights.
